

# Tutor/Assessor Requirements

### Tutor/Assessor (In most cases the same person)

### Tutors are required to hold a teaching or training qualification at Level 3 or above

- Level 3 Award in Education and Training or equivalent
- Level 4 Certification in Education and Training or equivalent
- Certificate in Education
- Postgraduate Certificate in Education
- SVQ/NVQ Levels 3 and 4 in Learning and Development
- Scottish Training Qualification for Further Education (TQFE)
- Masters in Education
- Level 3 Delivers of Conflict management DS/SO
- Level 3 Award for Deliverers of Physical Intervention Training DS

Tutors must also successfully complete a National Counter Terrorism Security Office (NaCTSO)/SIA-endorsed counterterrorism programme such as the ACT (Action Counters Terrorism) Awareness training which **must** be completed annually.

# Assessor Requirements

#### Assessor (In most cases the same person as tutor)

Assessors **must** hold one of the qualifications below. If they don't hold one of these qualifications currently, they **must** achieve one of the qualifications below by **30 September 2022**.

Assessors to hold any of the following qualifications:

- Level 3 Award in Understanding the Principles and Practices of Assessment (RQF)
- Level 3 Award in Assessing Competence in the Work Environment (RQF)
- Level 3 Award in Assessing Vocationally Related Achievement (RQF)
- A1 Assessing Learners Using a Range of Methods
- D32 Assess Learner Performance
- D33 Assess Learner Using Different sources of Evidence

# Assessor Requirements

#### Or the following units from a teaching qualification.

- Understanding assessment in education and training unit (from a Level 3 Award in Education and Training)
- Understand the principles and practices of assessment (from a 12 credit Preparing to Teach in the Lifelong Learning Sector)
- Principles of assessment in lifelong learning (from a 12 credit Preparing to Teach in the Lifelong Learning Sector)
- Understanding the principles and practices of assessment (from a Level 3 Certificate/Level 4 Diploma in Learning and Development)

- Assess occupational competence in the work environment (from a Level 3 Certificate/Level 4 Diploma in Learning and Development)
- Assess vocational skills, knowledge and understanding (Level 3 Certificate/Level 4 Diploma in Learning and Development)

# Tutor/Assessor Competency

#### New Tutors:

- 2 years frontline experience in the last 5 relevant to the qualification/unit they wish to deliver
- Experience to be gained in the UK
- Operational experience can be built from full or part-time work etc.
- Need to provide evidence for approval CV or Statement of Competence
- National Counter Terrorism Security Office (NaCTSO) / ACT (Action Counters Terrorism) awareness completed on an annual basis

### **Existing Tutors:**

- Demonstrate CPD 40 hours per year can be made up of training , increasing professional knowledge and working front line
- National Counter Terrorism Security Office (NaCTSO) / ACT (Action Counters Terrorism) awareness completed on an annual basis



# IQA Requirements

### IQA (Internal Quality Assurance) Requirements

Internal quality assurers (IQA's) **must** hold one of the qualifications below. If they don't hold one of these qualifications currently, they must achieve one of the qualifications below by **30 September 2022**.

- V1 Conduct Internal Quality Assurance of the Assessment Process
- D34 Internally Verify the Assessment Process

Or the following unit from an IQA qualification:

• Unit 2/Unit 4 Understanding the principles and practices of internally assuring the quality of assessment.



# IQA Competency

### IQA (Internal Quality Assurance) Competency

- Understanding of the security industry and sector competence relevant to the area they are quality assuring
- Do not need to hold delivery qualification
- For Conflict Management would need to have sector background
  - armed services
  - police service
  - security industry
  - prison service
  - other applicable services that may require conflict management
  - For Physical Intervention would need to have appropriate competency of PI which may come from experience in the sector such as:
    - Security Industry
    - Police service
    - Armed Services
    - Other

• (If new to training/assessing, 2 years in the last 5 operational experience required)




# Learner Pre-Requisites

### English/Welsh Requirements

Reading, Writing, Speaking, and Listening equivalent to the following;

- B2
- Level 1 ESOL
- Level 5 ESOL SCQF
- Functional Skills Level 1 in English
- Level 5 SQA Core Skills SCQF
- Essential Skills Wales Communication Level 1.

Evidence to be retained for 3 years.



# Learner Pre-Requisites

### First Aid

- A current and valid First Aid or Emergency First Aid certificate that meets the requirements of the Health and Safety (First Aid) Regulations 1981
- Learners should, as a minimum, have achieved an Emergency First Aid at Work qualification covering the following outcomes.
  - understand the role of the first aider, including reference to:
    - $\circ$   $\;$  the importance of preventing cross-infection
    - $\circ \quad$  the need for recording incidents and actions
    - $\circ$  use of available equipment
  - assess the situation and circumstances in order to act safely, promptly and effectively in an emergency
  - administer first aid to a casualty who is unconscious (including seizure)
  - administer cardiopulmonary resuscitation and use of an automated external defibrillator
  - administer first aid to a casualty who is choking
  - administer first aid to a casualty who is wounded and bleeding
  - administer first aid to a casualty who is suffering from shock
  - provide appropriate first aid for minor injuries (including small cuts, grazes and bruises, minor burns and scalds, small splinters).

Valid for at least one year from the start of the Security Learning. Evidence retained for 3 years by centre.



# Delivery Hours, Assessment and Virtual Learning

- All the qualifications have new delivery times
- All have elements that must be delivered face to face
- Much of the new qualifications can be delivered using virtual classrooms
- Practical assessments will need to be recorded
- Remote invigilation by Highfield will continue for those that wish to access the service (helps reduce face-to-face time)



# Delivery – Virtual Learning

#### SIA Pilot Success for Virtual Delivery and Assessment

- Proved that virtual learning and assessment is robust and has a place in the delivery of SIA licensable qualifications
- Worked with the SIA to identify the elements that can be delivered through virtual classroom
- Identified those elements that cannot be delivered in virtual learning and must be delivered face to face
- Contact time remains the same for all units
- Only certain outcomes must be delivered face to face
- Practical assessments delivered face to face
- Centres will need to be approved for remote delivery of the new qualifications


# Assessments

### The MCQ exams will be available as:

- paper-based invigilated by the centre
- online in the classroom, invigilated by the centre
- remote invigilated by Highfield Qualify at Home Package

Practical assessment documentation – will be available for download and will include:

- observation sheets
- scenarios for assessment



# Important Dates

- End of current qualification registrations 31 March
- New qualifications and top up from 1 April
- First aid requirement from 1 April
- End of current qualifications certification 31 August 2021
- Top up is a requirement on re-licencing from 1 October



### Centre Requirements for Remote Delivery/Virtual Learning

- Those centres wishing to deliver using virtual classroom must request approval via the account manager
- Centres must use an online platform that enables live and interactive delivery of training
- The platform must give access to personnel from both Highfield and SIA allowing them to 'drop in' at any time

- Only Highfield approved centres with no current sanctions in place will be allowed to deliver and assess remotely
- Centres will need to provide an exemplar session plan for the delivery as part of the approval process
- Centres must also provide details as to how you will meet the other requirements

# The 'Classroom'

• Learners on the virtual/remote learning course will 'attend' training at the same prescribed times, via their PC/laptop/tablet which must have a camera

- The trainer delivers the training from their own PC/laptop/tablet with a camera
- The trainer must be able to see all learners live on their own screen
- The learners must all be able to see the trainer live on their screen (but not necessarily the other learners)
